5.	<p>A complete set of Bidding Documents may be purchased by interested Bidders or his duly authorized representative on <b>Feb. 26 to Mar. 5, 2015</b> from the address below and upon payment of a non-refundable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Php10,000.00.</p>
