Bidders should have completed, within the last ten (10) years from the date of submission and receipt of bids, a contract similar to the Project. 	discretionary "pass/fail" criterion as specified in the Implementing Rules and Regulations (IRR
	of Republic Act (R.A.) 9184, otherwise known as the "Government Procurement Reform Act."
	Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organization with at least seventy-five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.
