	Bids received in excess of the ABC shall be automatically rejected at Bid opening.

Bidders should have completed, within the last ten (10) years from the date of submission an receipt of bids, a contract similar to the Project. Bidding will be conducted through open competitive bidding procedures using a nor discretionary "pass/fail" criterion as specified in the Implementing Rules and Regulations (IRR of Republic Act (R.A.) 9184, otherwise known as the "Government Procurement Reform Act." Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organization
	with at least seventy-five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.
