	Bids received in excess of the ABC shall be automatically rejected at Bid opening.
2.	The City Government of Calamba now invites bids for the above stated procurement. Completion of the Works is required within <i>Nine (9) calendar days</i> . Bidders should have completed, within the last ten (10) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3.	Bidding will be conducted through open competitive bidding procedures using a non discretionary "pass/fail" criterion as specified in the Implementing Rules and Regulations (IRR
	of Republic Act (R.A.) 9184, otherwise known as the "Government Procurement Reform Act." Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organization with at least seventy-five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.
4.	Interested Bidders or his duly authorized representative may obtain further information from the City Government of Calamba and inspect the Bidding Documents at the address give below from 8:00 AM - 5:00 PM.
5.	A complete set of Bidding Documents may be acquired by interested Bidders or hiddly authorized representative from the address below and upon payment of a non fee for the Bidding Documents pursuant to the latest Guidelines issued by the GPPB, in the amount of Php5,000.00.
